THE MIKEROWEWORKS FOUNDATION, A CALIFORNIA NONPROFIT PUBLIC BENEFIT CORPORATION ("MRWF"), WAS FOUNDED BY MIKE ROWE TO DEBUNK MYTHS ABOUT THE SKILLED TRADES AND WORK HARD TO HELP CLOSE THE SKILLS GAP. THE SPECIFIC PURPOSE OF MRWF IS TO PROVIDE FINANCIAL ASSISTANCE, THROUGH A VARIETY OF SCHOLARSHIP PROGRAMS, TO INDIVIDUALS PURSUING A CAREER IN THE TRADES AND TRADE-RELATED ORGANIZATIONS THAT SUPPORT THE TRADES. THE WORK ETHIC SCHOLARSHIP PROGRAM REWARDS PEOPLE WHO DEMONSTRATE AN ABILITY TO WORK HARD AND SMART AND UNDERSTAND THE IMPORTANCE OF SKILLED LABOR. MRWF ALSO PARTNERS WITH LIKE-MINDED ORGANIZATIONS AND/OR TECHNICAL SCHOOLS (E.G., SKILLSUSA, THE AED FOUNDATION, AND MIDWEST TECHNICAL INSTITUTE) TO OFFER OTHER TRAVEL, TOOL, AND/OR EDUCATIONAL SCHOLARSHIPS.
